Reference: Revision to the 2016 Annual Ambient Air Quality Monitoring Report for the Durham York Energy Centre

The 2016 Annual Ambient Air Quality Monitoring Report for the Durham York Energy Centre was submitted to the Regional Municipality of Durham on March 31, 2017 in advance of its required submission to the Ministry of Environment and Climate Change on May 15<sup>th</sup>, 2017. During the on-going preparation of the Q1 2017 report, Stantec has identified that in Tables 4-2 and 5-1 of the annual report, 98<sup>th</sup> percentile daily average PM<sub>2.5</sub> concentrations for 2016 based on monitoring year (from the start of monitoring, i.e. July 2015 to June 2016) were inadvertently entered rather than calendar year (January to December 2016). With the calendar year 98<sup>th</sup> percentile daily average PM<sub>2.5</sub> concentrations for 2016 included, the average annual 98<sup>th</sup> percentile daily average PM<sub>2.5</sub> levels for the 2014 to 2016 period were still were below their respective CAAQS criteria at both stations.

Please find attached with this letter a revised version of the 2016 Annual Ambient Air Quality Monitoring Report for the Durham York Energy Centre. The April 2017 report version updates Tables 4-2 and 5-1, along with the following associated revisions:
